



**HUNTERS** The key regulatory requirements to transporting firearms, firearm parts, or ammunition in **Checked Baggage** are:

- You must declare all firearms, including starter pistols, 3D-printed firearms, and weapon parts kits to the airline during the ticket counter check-in process.
- **Upper receivers, lower receivers, and frames by themselves are considered firearms, and must be declared to your airline during the ticket counter check-in process.**
- The firearm must be **unloaded**.
- Firearm parts, including magazines, clips, bolts, firing pins, silencers, and weapon parts kits that are readily convertible to firearms are prohibited in carry-on baggage, but may be transported in checked baggage.
- **The firearm must be locked in a hard-sided container before presenting it for screening.**
- The hard-sided container must be locked with no ability to gain access to the firearm.
- Gun cases may not be taped together and checked as one piece of checked baggage.
- During screening, TSA recommends providing the key or combination to the security officer to open the firearm container.
- Please remain present during screening to take the key back after the container is cleared. If you are not present and the security officer must open the container, TSA or the airline will attempt to contact you. If you cannot be contacted, the container will not be placed on the plane as federal regulations prohibit unlocked gun cases (or cases with broken locks) on aircraft.
- Firearm magazines and ammunition clips, loaded or empty, must be securely boxed or included within a hard-sided case containing an unloaded firearm. You must securely pack any ammunition in fiber, cardboard, wood, metal boxes or other packaging specifically designed to carry small amounts of ammunition. Loose ammunition is prohibited.
- You can't use firearm magazines/clips for packing ammunition unless they completely and securely enclose the ammunition.
- You cannot bring black powder or percussion caps used with black powder type firearms in either your carry-on or checked baggage.
- These regulations are strictly enforced by multiple agencies. **Violations can result in criminal prosecution and civil penalties of up to \$13,910 per violation.**



Airlines may have their own requirements on the carriage of firearms, the number of locks on a firearm container, and the additional amount of ammunition that you may have in your checked baggage. Therefore, travelers should contact the airline regarding its firearm and ammunition policies.

If your trip includes transporting weapons, allow extra time at the ticket counter and for potential additional screening. TSA recommends you check-in at least two hours prior to the scheduled departure time. Aircraft operators normally close their cabin doors 30 minutes before actual departure times. Since security screening wait times vary throughout the day, a good rule of thumb is to arrive at the security checkpoint at least one hour before your scheduled departure time.

## Hunters

TSA routinely encounters rifles, bows and arrows, knives and other items used by hunters and those who enjoy the outdoors. Please take a moment to become familiar with some of our security measures. Doing so now will help save you time once you arrive at the airport.

- You may transport unloaded firearms in a locked hard-sided container as **Checked Baggage Only**.
- Declare the firearm and/or ammunition to the airline when checking your bag at the ticket counter.
- **The hard-sided container must be locked with no ability to gain access to the firearm.**
- Locked cases that can be easily opened are not permitted. Be aware that the container the firearm was in when purchased may not adequately secure the firearm.
- Check your carry-on bags for loose ammunition or casings. Ammunition may only be transported in checked baggage in a package designed to transport ammunition. Loose ammunition in checked baggage is prohibited.
- The FAA limits ammunition quantity to a reasonable amount for personal use during a trip. However, international regulations and some airlines in the U.S. limit this to 5 kg (11 pounds) gross weight per passenger. Check with your airline.
- Avoid wearing clothing, jewelry, and accessories that contain metal. Metal items may set off an alarm on screening equipment.
- Carry your medications with you in your carry-on bag.
- Packaged meat/game & other non-liquid food items are permitted in both carry-on and checked bags. If the food is packed with ice or ice packs in a cooler or other container, the ice or ice packs **must** be completely frozen when brought through screening. If the ice or ice packs are partially melted and have any liquid at the bottom of the container, they will not be permitted. You also can pack frozen perishables in your carry-on or checked bags in dry ice.
- The FAA limits you to 5.5 pounds of dry ice that is properly packaged (the package is vented) and marked. Airline approval is required.

## Passenger Support

Travelers that may require special accommodations or are concerned about the security screening process at the airport may ask a TSA officer or supervisor for a Passenger Support Specialist who can provide on-the-spot assistance.

TSA Cares is a helpline that provides travelers with disabilities, medical conditions, and other special circumstances additional assistance during the security screening process. Call or email TSA Cares 72 hours prior to traveling with questions about screening policies, procedures and what to expect at the security checkpoint.

## At the Airport

Adult passengers who are 18 and over must show valid identification at the airport checkpoint in order to travel. Refer to [www.TSA.gov](http://www.TSA.gov) for acceptable forms of ID.



## Passenger Security Checkpoints

Unless you are TSA Pre✓, you will need to remove your shoes, remove your 3-1-1 compliant liquids, and personal electronic devices larger than a cell phone, such as laptops, tablets, e-readers and handheld game consoles, from your carry-on bag and place them into a bin with nothing placed on top of or under them for X-ray screening. In addition to screening personal electronic devices separately, TSA officers may instruct travelers to separate other items from carry-on bags such as foods, powders, and any materials that can clutter bags and obstruct images on the X-ray machine. Also, ensure that your pockets are empty (keys, tissues, currency, wallets, cell phones, etc.) and remove bulky jewelry before entering the screening process. Valuable items can be placed in your carry-on bags.
